3. ITEM 2 - PRESIDENT'S REPORT

The FIT President, Samantha Shields, provided an update on membership numbers and spoke to her report on the activities of FIT that had been provided to members. The report was in accordance with section 73 (c) of the Associations Incorporation Act 1991. A copy is attached.

Sam spoke of the further challenges in 2021 following on from those presented in 2020. The global COVID-19 pandemic continued to make an impact, leading to the cancellation of face-to-face training sessions, many loved events, and importantly, post-training breakfasts.

Sam acknowledged the efforts of FIT coaches to keep members engaged throughout the Canberra lockdown with virtual training sessions and training sets. She stated that 2021 marks the 25th year of FIT's incorporation. Throughout 2021, we swam, ran and cycled under the FIT 25th Anniversary Team name, including in the Canberra Running Festival and Laps for Life. Unfortunately, the 25th Anniversary cocktail party planned to coincide with FIT's 25th Anniversary in November 2021, had to be postponed to 2022.

Sam ended her report by acknowledging with thanks the contributions of the 2021 FIT Committee. Special mentions were made of outgoing Committee members: Josie Piccin, Heidi Livermore and Virginia Lindenmayer.

4. ITEM 3 - TREASURER'S REPORT

Item 3.1 Statement of Accounts

The FIT Treasurer, Jean Chesson, reported that the audited financial statements for 2020-2021 had been provided with the agenda papers for members' review. She reported that FIT had recorded a small loss (\$99) for 2020-21. However, the loss would have been larger had income for the year not included membership renewals (~\$3,000) received just prior to the end of the financial year which would previously have been reported in the following financial year (2021-22). Jean said that a further loss was budgeted for 2021-22 and that action would be needed in future to mitigate against future losses.
